# PLAINTIFFS' DAUBERT MOTION TO EXCLUDE THE OPINIONS AND TESTIMONY OF DR. DENNIS W. CARLTON

Plaintiffs hereby file this Motion to Exclude the Opinions and Testimony of Dr. Dennis W. Carlton. Defendant Delta Air Lines, Inc. ("Delta") has proffered three opinions by Dr. Carlton on legal and factual issues related to the merits. Because these opinions are neither relevant nor reliable, the Court should exclude and decline to consider them.

As discussed in depth in Plaintiffs' supporting memorandum, Dr. Carlton's opinions are not relevant or reliable for several reasons, and the Court should exclude them. First, Dr. Carlton's antitrust policy argument is contrary to law and is not based on reliable methodology. Second, Dr. Carlton's opinion that Delta would have implemented the first bag fee absent collusion is not grounded in the facts of this case and not based on reliable methodology. Third, Dr. Carlton's opinion that it would be uneconomic for Delta and Northwest to maintain separate fee structures immediately after the merger is not based on reliable economic methodology.

For these reasons and as further set forth in Plaintiffs' supporting memorandum, Plaintiffs respectfully request the Court strike the testimony of Delta's proffered expert, Dr. Dennis W. Carlton.
