PLAINTIFFS' MOTION FOR AN AWARD OF ATTORNEYS' FEES, THE REIMBURSEMENT OF EXPENSES, AND INCENTIVE AWARDS FOR CLASS REPRESENTATIVES

Plaintiffs Randy Waterman, Frank Audino Construction, Inc., Sioux City Engineering Co., the City of Le Mars, Iowa, Holtze Construction Company and Brown Commercial Construction, Inc. (collectively "Plaintiffs"), by Class Counsel, respectfully move this Court for the entry of an Order: (i) awarding Class Counsel attorneys' fees of \$6,166,667, which is onethird of the amount of the combined Settlement Funds established under the three Settlement Agreements; (ii) directing the payment of \$911,445.92 to Class Counsel in reimbursement of litigation-related expenses incurred through July 31, 2011, to be paid from the Settlement Funds in amounts proportionate to the size of each Fund; and (iii) directing the payment of \$10,000 to each of the Plaintiffs \$10,000 as an incentive award for services to the Classes, to be paid from the Settlement Funds in amounts proportionate to the size of each Fund. In support of this Motion, the Plaintiffs have submitted herewith their Brief in Support of Motion for an Award of Attorneys' Fees, Reimbursement of Expenses, and Incentive Awards for Class Representatives, and the Declaration of Irwin B. Levin in Support of Unopposed Motion for an Award of Attorneys' Fees, Reimbursement of Expenses, and Incentive Awards for Class Representatives. The Brief, at 26 pages exclusive of signature pages and certificate of service, is filed under a separate Motion for Leave to File Brief in Excess of 20-Page Limit.
