1 On August 20, 2012, the Court dismissed Plaintiffs' antitrust claim under Section 1 of the 2 Sherman Act, resolving the only claim asserted in many of the member cases in this consolidated action. 3 ECF No. 198. As the Court noted in its November 25, 2015 Order Following Appeal, ECF No. 231, 4 some of the member cases also include supplemental claims. Pursuant to Federal Rule of Civil 5 Procedure 41(a)(1)(A)(i), the plaintiffs in the Second Amended Consolidated Class Action Complaint and in the member cases hereby dismiss all remaining claims with prejudice. As a result of the Court's 6 7 August 20, 2012 Order and this voluntary dismissal, all cases and claims in this multidistrict litigation 8 have been resolved.
