7-Eleven, Inc. ("7-Eleven") announced today that it has signed definitive agreements to sell 293 Speedway and 7-Eleven stores to three separate buyers. This follows the completion of 7-Eleven's acquisition of Speedway from Marathon Petroleum Corp. (NYSE: MPC) on May 14, 2021.

On March 15, 2021, 7-Eleven signed a definitive agreement to sell 124 Speedway and 7-Eleven sites in the Midwest, Northeast, Florida and Utah to Anabi Oil, a family-owned and operated business based in Upland, California.

On March 17, 2021, 7-Eleven signed a definitive agreement to sell 63 Speedway sites in California, Arizona and Nevada to Jacksons Food Stores, a nationally recognized chain based in Meridian, Idaho.

On April 28, 2021 7-Eleven signed a definitive agreement to sell 106 Speedway (https://caplp.gcs-web.com/news-releases/news-release-details/crossamerica-partners-lp-announces-definitive-agreement-acquire) and 7-Eleven sites located in the Mid-Atlantic and Northeast to CrossAmerica Partners LP, a publicly traded limited partnership headquartered in Allentown, Pennsylvania.
