Mr. Cummins, who lives and works in Tennessee, argues that forcing him to testify at a preliminary injunction hearing in person would be a "significant burden" and that presenting his testimony via videotaped deposition should suffice. Rule 45 instructs district courts to quash a subpoena that "subjects a person to undue burden." Fed. R. Civ. P. 45(d)(3)(A)(iv). As the movant, Mr. Cummins bears the "heavy burden" of meeting this standard. <i>Northrop Corp. v. McDonnell Douglas Corp.</i> , 751 F.2d 395, 403 (D.C. Cir. 1984). He has not done so. Mr. Cummins is the Rule 30(b) (6) witness for a divestiture buyer in an antitrust merger case. He does not contest that his company's purchase agreement is material. Rather, he argues that his live testimony would be duplicative of his deposition and would require him to travel to Washington, D.C. immediately after he returns from a trip to China. Neither reason is persuasive. First, Plaintiff states that Mr. Cummins's testimony is among the most important in the case and that his deposition will not suffice. Second, the use of a videotaped deposition in lieu of live testimony would deprive the Court of the opportunity to assess his credibility and question him. Finally, on the record here, requiring Mr. Cummins to travel to Washington, D.C. would not be an "undue burden." <i>See United States v. Anthem, Inc.</i> , Civil Action No. 16-1493 (ABJ), 2016 WL 11164033, at *2 n.2 (D.D.C. Dec. 7, 2016). For example, he has not argued that others are unable to help cover his duties in his brief absence. Nor has he argued that he would have to cancel or modify other engagements. Indeed, he readily concedes that Plaintiff has endeavored to avoid disrupting his trip to China. While the Court appreciates that Mr. Cummins would prefer not to travel to testify in this case, he has not demonstrated the kind of exceptional circumstances that warrant quashing a subpoena, <i>see Flanagan v. Wyndham Int'l Inc.</i> , 231 F.R.D. 98, 102 (D.D.C. 2005). Accordingly, Jonathan Cummins's <a href="#">59</a> Motion to Quash FTC's Subpoena to Appear for Live Testimony is DENIED.
