In re Ranbaxy Gen. Drug Application Antitrust Litig., No. 19 Md. 2878 (NMG), 2020 WL 5370577, at *1, 4 (D. Mass. Sept. 8, 2020). Here, however, Defendants can rely on other information to define the relevant market and assess market share. While the Court has no doubt that counsel will respect and safeguard any data shared with them under the Protective Order's confidentiality provisions, it sees no legal basis to compel Gorilla Glue to disclose highly sensitive and potentially damaging information that is not directly relevant to the legal issues of this case.
